



MEMBERSHIP APPROVAL PROCESS



1) A written, completed, membership application in a form and manner approved by the Board of Directors accompanied by the initiation fee is required on behalf of any person applying for membership in the Club.

2) The completed application should be sent to:

3) After the application is received, the applicant(s) will be contacted to schedule an informational interview at the Club with the Membership Committee.

4) The application shall bear the signatures of one qualified sponsor and two qualified seconders. The sponsor and each seconder must have been a Regular or Life member in good standing for more than one year. (Qualified sponsor signatures may be obtained at the Membership Committee Interview).

5) Applicants for membership to the Club shall not be discriminated against on the basis of race, color, religion, age, ancestry, national origin, sex, political affiliation, sexual orientation, disability or any other grounds prohibited by law.

6) After the interview, the application will be forwarded to the Board of Directors and will be put to vote at the next Board of Directors meeting. The Board of Directors meets on the 2nd Wednesday of each month.

7) After the new membership application is approved by the Board, the new member(s) will be notified in writing and will receive a membership packet containing the Club Bylaws, Membership Directory, Membership Card(s), GGYC stickers and burgee.
